NEW PRESIDENT SELECTED FOR

WENATCHEE VALLEY COLLEGE

Dr. James R. Davis of Illinois was selected by the Board of Trustees of Wenatchee Valley College and has accepted the presidency of the college effective August 1, 1977, it was announced today by Tom Warren, chairman of the Board.

Davis, 39, is currently president of McHenry County College in Crystal Lake. When he joined the staff at McHenry in 1971, the institution's accreditation was on probation. A year later the state board investigating team reviewed the college's performances and was so impressed with the changes that had occurred that they gave the college a special commendation.

Davis also developed a community service program at McHenry that involves approximately 2300 active participants and 4000 total recipients of the service.

Davis earned a bachelor of arts degree in English and speech from the University of Dubuque and master and doctorate of education degrees from the University of Illinois.

LOOKS AT VALUE OF DEGREES

Ask almost any cab driver: The value of a college degree is not what it used to be. But it still has solid economic value, according to a study just published by the Conference Board.

According to Leonard Lecht, who prepared the study:

--Persons holding a college degree are only one third as susceptible to unemployment as are others.

--College men over 25 make about 36 percent more than their high school counterparts.

--People receiving college degrees over the next decade should retain an economic advantage because fewer young people--with or without degrees--will be entering the labor market, thanks to the declining birthrate.

--Between 1974 and 1985 about 2.1 million jobs will have opened for college graduates, including some totally new ones--physician's assistant, legal paraprofessional, and many types of managerial and specialized technical positions.

--Professional and technical employment is expected to grow more rapidly than blue-collar employment. Jobs for professional and techschool grads will increase by 29.5 percent between 1974 and 1985, against 20 percent for all occupations. Jobs in teaching, however, will continue to be scarce in the coming decade.

Ron Magden discussed television courses in the state and their relationship to the SBCCE as well as individual community colleges. Dr. Rhule said that the Instruction Commission has been asked by the State Board to work with a consortium for courses. Dr. Magden is representing Dr. Rhule at Channel 13 on June 2 when the Puget Sound Basin colleges meet to discuss TV courses for 1977-78.

Since there will be no further meetings of the Curriculum Committee, and these courses may be available for Fall Quarter, Dr. Magden asked that experimental courses be authorized, but assured the committee that no course would be adopted or offered without the approval of the division/department affected.

MOTION: It was moved by Jack Hyde and seconded by Lloyd Berntson that Economics 198 and Administration of Justice 198 be approved by the Curriculum Committee. The motion carried unanimously.

1. Dr. Rhule reminded the Committee members of the faculty meeting Thursday, June 2.

2. Bill Muse reminded the Committee of the music program on June 1 at 8 p.m. in the little theater.

3. Dr. Rhule announced Joan Royce's resignation effective June 30, 1977. He thanked her for all she has done for the institution and acknowledged her leadership in the Allied Health area. Dr. Rhule expressed how very difficult it will be to replace her.

4. Mr. Brown's memorandum regarding the personal holiday was referred to. Dr. Rhule asked

that time off not conflict with final examinations.

There being no further business, the meeting was adjourned for the 1976-77 academic school year at 3:40 p.m.

TACOMA COMMUNITY COLLEGE FACULTY MEETING

June 2, 1977

The meeting was called to order at 3:35 p.m., by Dr. Robert R. Rhule

- I. Observations and Announcements
 - A. Dr. Rhule expressed his appreciation to the faculty for meeting the student needs for the past academic year. He also thanked the faculty for completing his evaluation and promised more accessibility for next year.
 - B. Mr. Elijah Hankerson was commended by Dr. Rhule for his work at Tacoma Community College for the past eight years with minority students and to the total institution.
 - C. Dr. Rhule informed the faculty that Mrs. Joan Royce, Allied Health Chairman, has resigned as of June 30, 1977, and expressed regret at her leaving.
 - D. Dr. Rhule introduced Mrs. Lucy Charnley, who has worked as an intern from the State Board for Community College Education in the Occupational Office at TCC while Lorraine Stephan worked as an extern at the State Office. He thanked her for her effort on campus.
 - E. Dr. Rhule introduced Mrs. Ellen Pinto, Chairman of the TCC Board of Trustees, and thanked her for her contribution to the total campus.
 - F. Jerry McCourt, TCCFT President, announced a bargaining unit meeting of the TCCFT on Tuesday, June 7, at 2:30 p.m., in Building 12, for discussion of evaluations and progress of negotiations. He urged all faculty members to attend.
 - G. Dr. Ronald E. Magden, Chairman of the Commencement Committee, thanked the faculty for their support. He said that only the people who have received special notes are required to attend the dress rehearsal for commencement.
 - H. Dr. Rhule congratulated Murray Morgan, Luther Jansen, and Frank Weihs on their professional leaves for 1977-78 and wished them well in their projects.

A. Handouts were distributed by the Chairman of the Faculty Evaluation Committee -Carolyn Anderson. She expressed her appreciation for the faculty's cooperation,
and mentioned that Tom Hanson's name should be added as a member of the committee.
Mrs. Anderson said that the Committee has been working since January, 1976 and
then went through a step-by-step appraisal of the work of the Committee. She
said she felt that the instruments had been refined to the point where they now
have applicability to all teaching modes. Copies of the evaluation sheets are
available from her. Mrs. Anderson stressed that the purpose for evaluation is
to improve instruction to students.

III. President's Spring Quarter Address to Faculty

A. Dr. Stevens expressed his appreciation to the faculty for attending the meeting, and also expressed his appreciation to Mrs. Ellen Pinto, Chairman of the TCC Board of Trustees for attending.

After comments on the past year's activities, he addressed four subjects of concern for the 1977-78 academic year:*

- (1) Budget
- (2) Staffing
- (3) Long-Range Planning
- (4) Board of Trustees' Role

He noted that in the Fall there will be a contract day that will be used as an off-campus retreat day for faculty to address several subjects on which they had expressed concern.

In conclusion, he thanked the faculty for their work with students, for their work on committees, for their work on the Long-Range Planning Commission, and for their willingness to participate in commencement. Dr. Stevens wished each person a pleasant summer.

The meeting adjourned at 4:25 p.m.

SAFETY AND INDUSTRIAL HYGHENE AT SUMMER CONFERENCE SPOKANE

A new instructional package designed to meet certification requirements for safety and industrial hygiene (SEIII) will be offered during the two days preceding the summer vocational conference. The course will meet only the horizontal (general) requirement for safety and begin at 8:30 a.m. on August 19 in Spokane's Davenport Hotel, Progress Room. Enrollment will be limited to two sections of 30 each on a first-come, first-served basis to community college and common school personnel.

The package was developed at the Duwamish Apprenticeship and Training Center of South Scattle Community College and has been tested with three different groups of vocational teachers. Fifteen hours of group instruction are required to complete the course.
