MINUTES OF MEETING June 24, 1971

The regular meeting of the Board of Trustees was held on Thursday, June 24, 1971, in the Northwest History Room at Tacoma Community College.

CALL TO ORDER

The meeting was called to order by Chairman Yamashita at 3:45 P.M. The roll was called with Trustees Yamashita, Tuggle, and Anderson present; Trustees Binns and Edmunds absent. Mr. Binns arrived a few minutes later to take his place at the table.

APPROVAL OF MINUTES

Motion: Mr. Anderson moved and Dr. Tuggle seconded that the minutes of

the meeting of May 27, 1971, be approved as mailed out.

Motion carried unanimously.

CORRESPONDENCE

Dr. Ford told the Trustees of a letter to Dr. Falk from the U. S. Department of Health, Education, and Welfare informing him that TCC's application for federal funds for planning an Associate Degree Nursing program has been recommended for approval by the National Advisory Council on Nurse Training, although it has not been funded.

Other correspondence was a letter from the University of California at Los Angeles advising of the bibliography they are preparing on a "Junior College Leadership Program."

UNFINISHED BUSINESS

None.

NEW BUSINESS

Motion: Mr. Binns moved and Dr. Tuggle seconded that agenda supplement 5-a-1 be approved (supplementary faculty for TCC credit courses for Summer Quarter, 1971).

Motion carried unanimously.

Motion: Dr. Tuggle moved and Mr. Binns seconded that the Board accept the supplement for Community Services (5-a-2, supplementary faculty for Community Services credit courses for Summer Quarter, 1971).

Motion carried unanimously.

Motion: Mr. Binns moved and Mr. Anderson seconded that the Board adopt Resolutions No. 71-13 and No. 71-18 (agenda supplements 5-b and 5-i--resignations of Susann L. Skrivseth and Patricia A. Dyer).

Motion carried unanimously and the resolutions were adopted.

Motion: Dr. Tuggle moved and Mr. Anderson seconded that Resolution No. 71-14, the request for a leave of absence without pay for Mrs. Dedre Marriott (agenda supplement 5-c), be adopted.

Motion carried unanimously.

Motion: Mr. Binns moved and Dr. Tuggle seconded that the Board adopt Resolution No. 71-15 (agenda supplement 5-d) appointing Monty B. Jones as evening school supervisor for the 1971-72 academic year.

Motion carried unanimously.

Motion: Mr. Binns moved and Mr. Anderson seconded that the Board adopt Resolution No. 71-16 (agenda supplement 5-e) appointing Robert R. Rhule to the new position of Director of Occupational Education.

Motion carried unanimously.

In regard to Mr. Rhule's appointment, the Chair said it represented implementation of Board policy as established on November 19, 1970, when the Trustees adopted a new statement of objectives and priorities for the college.

President Ford added that the adoption of this resolution by the Board will enable the college to begin the occupational part of the program and that it will attract more state and federal funds as well.

Renewal of the professional negotiations agreement with the TCCA was discussed by Dr. Ford. A copy of the original agreement signed on July 27, 1967, is enclosed with these minutes.

There was discussion of TCC's Board of Trustees bylaws. Assistant Attorney General Robert Patterson advised the Trustees that thirty (30) days notice shall be given by a public body in order to amend its bylaws. He further advised that these bodies shall establish the days and times for their regular meetings to be included in the bylaws.

Motion: Mr. Binns moved and Dr. Tuggle seconded that Article VI, Section 4, of the bylaws of Tacoma Community College Board of Trustees be amended to read: (Amendment underlined.)

"... shall hold at least one regular meeting during each month of the year; the date of the regular monthly meeting shall be the fourth Thursday of each month at 3:30 P.M.; and such other regular or special meetings . . . "

And, further, that this amendment be a special order of business at the next regular meeting.

Motion carried unanimously.

Mr. Van Mieghem discussed Resolution No. 71-17 (agenda supplement 5-h) regarding the preliminary revenue package and allotment request for Tacoma Community College. State law, he said, requires that the college submit this information to the State Board on June 24, 1971, as it must be in the Office of Program Planning and Fiscal Management (OPP&FM) on June 28, 1971. He stated that the budget has not been completed but it "has been brought down almost to revenue size." Salary increments have been included for people who have them due but not salary increases, and he added that negotiations with the faculty on salary requests are continuing. The revenue statement predicts a total income to the college of \$3,394,132 for the 1971-72 biennium -- \$2,763,184 from the state allocation and the remainder to come from local income, federal, and other. Mr. Van Mieghem noted that general administration and plant maintenance and operation budgets for 1971-72 are below the current

year; student services is about the same; the Library and Instructional Resource Center have been cut to about \$41,000 below the current year; and instruction is up some \$79,000 (includes the occupational area).

Motion: Mr. Anderson moved and Dr. Tuggle seconded that the Board adopt Resolution No. 71-17, the preliminary allotment request.

Motion carried unanimously and the resolution was adopted.

Dr. Lathrop explained the new admissions criteria for foreign students, and the reasons for them.

Motion: Mr. Anderson moved and Mr. Binns seconded the adoption of Resolution No. 71-19 (agenda supplement 5-j re. admissions criteria for foreign students).

Motion carried unanimously.

Dr. Falk introduced a resolution which Mr. Patterson brought to the administration's attention regarding contracts for twelve-month salaried people.

Motion: Mr. Binns moved and Dr. Tuggle seconded the adoption of the following
 resolution:

RESOLUTION NO. 71-20

BE IT RESOLVED by the Trustees of Tacoma Community College, That the authority be delegated to the President of the college to renew and/or enter into contracts of employment commencing July 1, 1971, with administrative and support personnel, with the exception of the President, on such terms as he deems to be in the best interest of the institution.

Motion carried unanimously.

There was some discussion in regard to a contract for the President.

Motion: Mr. Binns moved and Dr. Tuggle seconded that Dr. Thornton M. Ford be re-elected as President of the college for the next year, 1971-72, at his present salary.

Motion carried unanimously.

Dr. Ford said he was honored to serve his eighth year as President.

REPORTS

ASB.--Mr. Whitbeck noted that student government has been meeting monthly during the summer instead of closing up during this time as has been done in the past.

WACCSG .-- No report.

TCCA.--Mr. Jansen, President, said the chairman of the TCCA negotiating committee, Vern Hess, is in Europe, and has resigned from the committee. George Huffman was named the new chairman and the other new member is Frank Garratt.

TCCSA. -- No report.

<u>Instruction</u>.--Dr. Jacobson reported that the summer program is larger than ever. He said that the problems are budget, contracts, and fall quarter.

<u>Student Services</u>.--Dr. Lathrop said this summer quarter's enrollment of 1,423 students has exceeded the 1970 summer quarter registration by 338. The total increase in FTE's for this period is 200.

<u>Community Services</u>.--Mr. Rhule thanked the administration and the screening committee for recommending him for the Director of Occupational Education position to which the Board appointed him today.

He said there are two Community Services programs at present at the Treatment Center for Women in Purdy--psychology and contemporary history, with communication skills to be next.

Chances look good, he said, for federal approval of a grant for a \$103,000 project in which TCC would provide educational services to low-income housing areas (Conifer program).

Administrative Services. -- Mr. Van Mieghem noted that the state auditor is still in the office.

"If the rain ever stops," he said, "we will get the finish on the tennis courts."

<u>Instructional Resource Center.--Mrs. Amoroso's report is contained in agenda</u> supplement 6-i, a report on Minority Acquisitions to the library from March 24, 1971 through June 10, 1971.

<u>Planning and Program Development.--Dr.</u> Falk said the institution has experienced a good deal of change in the development of programs, especially in the occupational area.

<u>President's Report.--Dr.</u> Ford noted the memorandum sent to the Board regarding negotiations and said he was very optimistic--that they are making good progress and hope to be ready to present a proposal at the next Board meeting.

He also reported that the schooling on management is going well and they are now planning ways to put these new ideas into practice. Five of the administrators, he said, would be attending a regional meeting to further these plans, and TCC has set up a two-day retreat in this regard for early July.

When the Budget Advisory Committee has another level of review, a budget study session will be set up with the Board of Trustees.

INFORMATION

Mr. Anderson made the suggestion that a place be put on the Board's agenda called "Trustee Comments." It was noted that this will begin with the July 1971 meeting.

NEXT MEETING

The next meeting of the Board will be held on July 22, 1971, at 3:30 P.M. in the Northwest History Room at the college.

ADJOURNMENT

Motion: Dr. Tuggle moved and it was seconded that the meeting adjourn.

Motion carried unanimously.

COOPERATIVE BOARD-CERTIFICATED PERSONNEL RELATIONS

Between the Board of Trustees Tacoma Community College District 22 and the Tacoma Community College Association

The Board of Trustees of the Tacoma Community College District 22 and the Tacoma Community College Association do hereby agree that the educational welfare of the students of Tacoma Community College is of paramount importance and shall be accepted as the basic consideration by both parties. Pursuant to Chapter 143, Laws of 1965, Revised Code of Washington, the parties do hereby agree as follows:

I RECOGNITION

The Board of Trustees of Tacoma Community College District 22, hereinafter known as the Board, recognizes that teaching is a profession and that the Tacoma Community College Association, hereinafter referred to as the Association, having received the majority of votes cast by the certificated staff of the college, shall be the representative of all the certificated personnel employed, or to be employed, by the Board. The association recognizes the Board as the duly authorized governing body of Tacoma Community College District 22 and as the employers of all certificated personnel. The purpose of recognition is the mutual agreement that the parties will negotiate with regard to matters as outlined in Section II-C.

II PRINCIPLES

A. Attaining Objectives

Attainment of objectives of the educational program of the district requires mutual understanding and cooperation between the Board and the professional personnel. Free and open exchange of views is desirable and necessary, with all parties participating in deliberations leading to the determination of matters of mutual concern.

B. Professional Teaching Personnel

Teaching is a profession requiring specialized qualifications, and the success of the instructional program in the college depends upon the maximum utilization of the abilities of certified personnel who are satisfied with the conditions under which their services are rendered.

Certified personnel have the right to join, or not to join, any organization for their professional or economic improvement, and membership in any organization shall not be required as a condition of employment.

C. Representation

The Board and the president, or their designated representatives shall meet with representatives of the Association to negotiate in good faith on policies governing professional compensation, faculty leave, conditions of employment, the recruitment of instructors, deans, president, community support for the school program, budget preparation, communications, and other matters which affect the quality of the educational program.

III PROCEDURES

A. Association Participation

When requested by either party, the president of the college and/or the Board of Trustees shall meet with Association representatives to confer on matters outlined in Section II-C. Matters not satisfactorily resolved at these meetings may, at the request of either party be the subject of negotiation between a committee of Board members, the president of the college, and Association representatives.

B. Meetings

Meetings between the Association representatives, the Board, and the president of the college shall be called upon the written request of any one of the parties involved. Requests for meetings shall include specific statements of the reasons for the requests.

C. Directing Requests

Requests from the Association for meetings between Association representatives, the Board, and the president, shall be made to the president of the college.

Requests from the president of the college or the Board shall be made to the president of the Association. A mutually convenient meeting shall be arranged within fifteen days of the date of the request.

D. Statements of Positions

Proposals, counterproposals, information and supporting data shall be exchanged freely and in good faith during the meeting or meetings in an effort to reach mutual understanding and agreement. The Association negotiations committee, the president of the college, and where applicable a committee of the Board shall act, insofar as possible, as a committee of the whole.

E. Requests for Assistance

All participants have the right to utilize the services of their own consultants in the deliberations.

- F. Agreement reached by the participants shall be put in written form and shall be subject to ratification by the Board and the Association.
- G. Nothing in this agreement shall be interpreted as denying the right of a certificated employee to appear before the Board on his own behalf on matters as outlined in Section II-C. In the event such matters shall affect other certificated staff members, the Association shall have the right to express its considered professional judgment before the Board prior to the Board's final decision on an individual case.

IV RESOLUTION OF DIFFERENCES

A. Special Committee

If the participants reach an impasse or if they reach agreement but such agreement is not ratified by both parties, either party may within five days thereafter request the Office of the State Director of Community Colleges or whoever else may be the duly authorized authority, by registered mail, to appoint a special committee to assist and advise in the resolution of differences. Said committee shall make a written report with recommendations to both parties within fifteen days of receipt of the request for assistance.

V ACADEMIC FREEDOM

The Board recognizes and respects the right of citizens to make suggestions for the improvement of the college, but the Board also recognizes that the educational profession has both the right and the responsibility to insist that students must be free to learn and faculty members free to teach broad areas of knowledge, including those which may be considered controversial. Whenever any group or individual brings charges against a faculty member concerning the faculty member's freedom to teach, if the Board concurs with the faculty member's position, it may provide, without charge to the faculty member the necessary and sufficient leave, legal assistance, and other support for the protection of academic freedom.

VI RENEWAL

The provisions of this agreement shall continue in effect for one year following the date of signing and shall be renewed at the regular meeting of the Board of Trustees in the month of renewal unless challenged by an employee organization showing proof of at least thirty percent membership of the college's certificated personnel. This agreement may be amended or supplemented at any time by mutual agreement of the parties thereto. It may be terminated at the end of each annual period by either party by giving written notice of intent to terminate not less than thirty days prior to the renewal date.

VII CONTRACT RIGHTS

It is mutually agreed that all contract rights which were held by members of the faculty with the Tacoma School District Number 10, and which have not been specifically amended or superseded under this agreement, remain in force.

VIII SAVING CLAUSE

If any provision of this agreement or the application thereof to any person or circumstance is held invalid, the agreement can be given effect without the invalid provision or application; and to this end the provisions of this agreement are declared to be severable.

In the event a portion of the agreement is held to be invalid, then the parties to this agreement shall renegotiate to bring that portion into conformity with the law.

Dear Mr. Pederson:

The resolution on faculty participation and financial exigency adopted by the Fifty-seventh Annual Meeting of the American Association of University Professors on April 17 of this year has been brought to my attention.

I wish to advise you that, despite the financial stringencies imposed by the 1971 Legislature, no reductions in the instructional staff for 1971-72 are contemplated at Tacoma Community College.

Additionally, I should note that formation of the operating budget at Tacoma Community College is reviewed by a Budget Advisory Council composed of faculty and staff. The budget is compiled in accord with a Statement of Institutional Objectives, which has been endorsed by the faculty and adopted by the college's Board of Trustees.

Finally, let me suggest that it would be well for the AAUP, in the case of publicly supported institutions of higher learning, to concentrate its efforts and energies upon influencing state legislators to fund higher education adequately. In my view, at least, local boards and administrations are left with the task of simply allocating scarcity in the best manner that they can.

Resolution on

Faculty Participation and Financial Exigency

The Fifty-seventh Annual Meeting of the American Association of University Professors shares the concern of all segments of the academic community over the effects of the severe economic difficulties presently confronting higher education. We are equally concerned, however, about arbitrary or simplistic actions by a governing board or a finance officer. Specifically, we refer to unwarranted cutbacks in educational programs, including the significance of those cutbacks for teaching personnel, both tenured and nontenured. The 1940 Statement of Principles on Academic Freedom and Tenure provides that tenure may be terminated "under extraordinary circumstances because of financial exigencies" and that "financial exigency should be demonstrably bona fide." However, the 1940 Statement was never intended to be an open door for wholesale or arbitrary dismissals, and the 1966 Statement on Government of Colleges and Universities makes it perfectly clear that the most intensive faculty participation is required in such grave decisions. Moreover, we deplore the apparent tendency of many boards and administrations, which, when faced with an apparent budgetary crisis, turn first to retrenchments in the instructional budget and to the reduction of instructional staff rather than weighing very carefully the whole range of possible alternatives.

The Fifty-seventh Annual Meeting therefore calls upon all institutions—including those not yet faced with the necessity of major budgetary reductions—to adopt orderly procedural standards for the review of priorities, and to insure that the principle of sound decision—making be applied in this currently critical area as well. Adequate faculty participation should be both substantive and procedural: whether retrenchments should be made, where they should be made, and how they should be made, are all matters of shared authority.

The following admission requirements for foreign students are recommended by the Foreign Student Admission Committee: Foreign students applying for admission to Tacoma Community College will be furnished the information listed below with the necessary forms to complete the requirements.

- 1. Complete academic records shall be furnished prior to admission to TCC.
- 2. A brief biography of educational and working background shall accompany the request for admission.
- 3. A statement of financial resources shall be furnished on a form prepared by the college.
- 4. Financial responsibility must be established by one of the following methods:
 - a. Deposit the amount required for one year's (three quarters) non-resident tuition and fees (\$681) with the college business office.
 - b. Deposit \$681 in a local bank and provide for withdrawal of \$227 for registration purposes only.
 - c. Provide a statement of financial responsibility co-signed by a local sponsor.
- 5. Scores on the TOEFL shall be furnished if their original language is not English.
- 6. A health examination report shall be furnished on a form prepared by the college.
- 7. Health insurance shall be purchased by the student as a condition of continuing enrollment.

These admission criteria shall apply to all foreign students applying for admission to Tacoma Community College. Requests for any exception from the above may be made in writing to the Foreign Student Admission Committee.


