CALL TO ORDER

The meeting was called to order by Chairman Binns at 3:45 P.M. A quorum was present with all members of the Board in attendance.

APPROVAL OF MINUTES

Minutes of the meeting of March 25, 1971, were approved as circulated.

CORRESPONDENCE

Dr. Ford noted a letter of commendation from Senior Centers, Inc. (an Office of Economic Opportunity program) expressing the appreciation of seniors taking part in a Community Services course called "Nature of the Place," and asking for a repeat.

Dean Van Mieghem explained the Higher Education Personnel Board correspondence relating to the bargaining unit for custodial/maintenance personnel. This is the same unit, he said, that has been representing these employees in the past, prior to the creation by the Legislature of the Higher Education Personnel Board in September, 1969. The HEPB, who now has jurisdiction in these matters, felt they should take official action to certify the International Union of Operating Engineers, Local No. 286, as the exclusive representative of TCC's custodial/maintenance employees. No TCC Board action is required at this time since approval has already been granted to this organization by the Trustees.

Other correspondence included a memorandum from Dr. John Terrey to district presidents on "legislative actions relating to budget." This will be covered in the President's Report.

UNFINISHED BUSINESS

Dr. Jacobson, in explaining the 1971-72 academic calendar, said that it is complete except for advising and registration days for Winter and Spring Quarters. A committee is currently working on this.

Motion: Mr. Anderson moved and Mr. Yamashita seconded that the Board adopt Resolution No. 71-6 (academic calendar for 1971-72) as contained in supplement 4-a.

Motion carried unanimously and the resolution was adopted.

Dr. Jacobson reported that Mary Palo has withdrawn her request for a sabbatical leave for 1971-72 which was granted by the Board February 25, 1971. Mr. William Anderson now requests one-quarter sabbatical leave and there is another request for two quarters.

The Chair requested that this item be passed until the next meeting because of possible legislative action prohibiting any sabbatical leaves for this biennium.

NEW BUSINESS

At this time Mrs. Mary Ann Schrawyer, representative of the TCC forensics team, was introduced. This team recently won the State Community College Forensics Championship. It is the second time in three years that TCC has won the state championship.

Motion: Dr. Tuggle moved and Mr. Yamashita seconded that the Board adopt Resolution No. 71-8 (supplement 5-c) commending the forensics team for winning the state championship.

Motion carried unanimously and the resolution was adopted.

NOTE: The Chair asked that the resolution be prepared for the signature of all Trustees and that copies be provided to each of the members of the team and their coach.

After discussion regarding the propriety of the Board's taking a stand on a political issue (Tacoma Public Schools special levy), the following action was taken:

Motion: Mr. Edmunds moved and Dr. Tuggle seconded that the Board adopt Resolution No. 71-7 (supplement 5-a) urging voters to go to the polls April 27th and cast an affirmative vote for the special levy for the Tacoma Public Schools.

Motion carried unanimously and the resolution was adopted.

Dr. Jacobson reported on the candidates recommended as supplementary faculty for TCC credit courses for Spring Quarter, 1971.

Motion: Mr. Yamashita moved and Dr. Tuggle seconded that agenda supplement 5-b-1 be accepted as listed.

Motion carried unanimously.

In Dr. Lathrop's absence, Dr. Ford reported on the recommendations for supplementary faculty for TCC Student Services for Summer Quarter, 1971.

Motion: Mr. Edmunds moved and Mr. Yamashita seconded that the Board approve of agenda supplement 5-b-2 as listed.

Motion carried unanimously.

Mr. Rhule reported on the candidate recommended for a Community Services non-credit course in Physical Education at TCC Spring Quarter, 1971.

Motion: Dr. Tuggle moved and Mr. Edmunds seconded that the Board approve of agenda supplement 5-b-3 as listed.

Motion carried unanimously.

Dean Van Mieghem discussed the results of bids on a T.V. Distribution System (Project No. 70-202) and called attention to a letter from the State Department of General Administration recommending the rejection of the low bid of Tyee Construction Company of Bellevue because Tyee's bid did not meet equipment specifications. The Department recommended the acceptance of the second low bidder, Totem Electric of Tacoma, Inc., at a price of \$16,600.

Assistant Attorney General Robert Patterson explained the position of the Department of General Administration in regard to rejection of bids.

After considerable discussion regarding the role of the Department of General Administration usurping the local Board of Trustees authority in rejecting bids, the following action was taken:

Motion: Mr. Yamashita moved and Mr. Anderson seconded that the Board accept the second low bid, Totem Electric of Tacoma, Inc., at a price of \$16,600, for a T.V. Distribution System, Project No. 70-202, <u>Provided</u>, That the proper procedures for the future be pointed out to Mr. Brown of General Administration.

Motion carried unanimously.

NOTE: Dean Van Mieghem was asked to draft the letter to Mr. Brown with approval to come from the Chair.

President Ford reported on changes in Associate Degree requirements (see supplement 5-e). These changes, he said, have gone to the faculty, the Associated Student Body, and to the Administrative Council, and are now before the Board for approval. They were made for the purpose of being able to make better judgments for each candidate, such as the occupational student.

Mr. Whitbeck, newly installed ASB President, asked for (1) clarification of when the changes in degree requirements will take effect, (2) student representation on the Associate Degree Committee, and (3) formation of a grievance committee for students.

Dr. Jacobson replied that students were not put on this committee because of the confidential records handled.

The Chair suggested the faculty take another look at the subject. Dr. Jacobson was asked to work with Mr. Whitbeck on an appeal procedure, with a report to be brought to the next Board meeting.

In discussing the many different degrees offered in the Washington State system, Dr. Ford indicated the State Board is working in the direction of standardization of degrees in the community college system.

Motion: Mr. Edmunds moved and Dr. Tuggle seconded that the Board accept the changes as noted in the Associate Degree requirements contained in supplement 5-e.

Motion carried unanimously.

Loyd Percy talked to the Trustees about the Northwest Athletic Association of Community Colleges (NWAACC) and the reasons for asking the Board to approve TCC's application for membership in this association, which is put together on a regional basis.

Motion: Mr. Anderson moved and Mr. Yamashita seconded that Resolution No. 71-9 (supplement 5-f) be adopted by the Board empowering the president to sign an agreement for TCC to join the NWAACC.

Motion carried unanimously and the resolution was adopted.

<u>ASB</u>.--Mr. Whitbeck, the new president, said that student participation in campus governance will be the number one priority of student government. He recommended a college Central Senate with equal representation to come from students, faculty and administrators.

WACCSG.--Dianna Jaycox, newly elected student senator, reported that WACCSG is taking part in "Earth Week." She said students are also working on an amendment to S.B. 152 (originally proposed by Representative Wojahn) to try to obtain funds for relocatable buildings for a temporary student union. She asked that telegrams be sent to Senator Durkan in this regard.

The Chair said the Board will send such a telegram.

<u>TCCA</u>.--Mr. Jansen, President, reported that Dr. Ronald Magden is chairman of the legislative committee. He said the faculty will schedule a meeting after President Ford has had an opportunity to be heard.

TCCSA.--Mrs. Hildebrand, President, advised that classified employees are busy sending telegrams and letters to legislators.

Instruction. -- No report.

<u>Student Services.--Mr</u>. Kosai reported for Dr. Lathrop. He said enrollment for Spring Quarter is down about 6 per cent from Winter Quarter, and that applications for next fall are about 2 per cent ahead of last year. They are working with the high schools and anticipate an increase.

<u>Community Services</u>.--Mr. Rhule, Director, reported they have more requests than they have time for.

Administrative Services.--Dean Van Mieghem reported on TCC's application for Title VI funds for specialized audio-visual equipment. He said there were 29 applications in the State of Washington with TCC's grant application scoring second highest in the state. This resulted in a grant in the amount of \$5,862.

Instructional Resource Center.--Mrs. Amoroso's report is contained in supplement 6-i.

<u>Planning and Program Development</u>.--Dr. Falk's report is contained in supplement 6-j--"Status of Developing Programs and Related Activities." This report has information regarding the (1) Community Outreach Program--Disadvantaged, (2) Career Development Program--Disadvantaged, (3) Interpersonal Growth and Development Program--Handicapped, (4) Adult High School Completion Program, and (5) Pre-Employment and Related Occupational Program Developments. The unanswered questions, Dr. Falk said, are the money questions.

<u>President's Report</u>.--Dr. Ford discussed the contents of his memorandum to the Trustees dated April 21, 1971--"Appropriations--Senate Version." (See supplement 6-k.)

An open meeting for any interested persons is scheduled for 3:00 P.M. April 29 in the Little Theater to discuss the implications of the operating budget which is now in a Joint Conference Committee.

The Senate figure for the Community College System, Dr. Ford said, stands at \$115,396,486--or \$3,026,156 less than the Governor's proposed budget and \$1,636,401 less than the House approved version.

As the bill presently stands, the highest estimate TCC could receive in increased dollars is \$51,858, and this only if the college serves the projected increase of 191 FTE's.

Expenditure of funds for sabbatical leaves will be prohibited. There is to be a reduction in state salaries by varying percentages for all individuals whose present compensation exceeds \$15,000 per annum. It appears doubtful that TCC can provide increments without the assist of additional funds (Mr. Van Mieghem estimates that increments alone would cost TCC \$46,000 next year).

It may become necessary to eliminate classes with small enrollments and some staff may have to be reassigned to occupational courses and programs. There will have to be a curtailment of all purchases, including library acquisitions.

Some other alternatives include: (1) non-renewal of contracts with Tacoma and Peninsula school districts for adult education programs, (2) cancellation of institutional memberships in state and national professional organizations, (3) continuation of the current stringent travel policy, and (4) close examination of any means by which management and instructional economies can be effected. Dr. Ford told the Trustees that "It is my sincere intention at this time to see to it that the budget for TCC will enable us to operate next year without a curtailment of faculty or staff."

THIS MATTER Coming on before the Higher Education Personnel Board on its own motion for recognition of a bargaining unit composed of all custodial/maintenance personnel at Tacoma Community College, and the Board having fully investigated the circumstances, reviewed the files and records herein, and being fully advised in the premises, now, therefore, the Board enters its Findings, Conclusions and Order of Recognition.

FINDINGS

Ι.

On August 6, 1968, a list of employees contained in a custodial/maintenance personnel bargaining unit at Tacoma Community College was submitted by George Van Mieghem, Dean of Administrative Services, Tacoma Community College, to Willard Olson, Mediator for the Washington State Department of Labor and Industries, and an election was held. On September 24, 1968, a Certification of Representative was issued. The bargaining unit has remained intact and at the present time contains nineteen employees, sixteen of whom pay dues to the exclusive bargaining representative, International Union of Operating Engineers, Local 286.

On March 1, 1971, George Van Mieghem stated that the following classifications are in this unit:

A substantial number of the employees in the above classifications desire the establishment of this bargaining unit, and the officials of the International Union of Operating Engineers, Local 286, and the administration of Tacoma Community College concur in the recognition of the bargaining unit.

IV.

V.

All of the employees who will comprise the unit are engaged in maintenance, operation and custodial services, and work similar hours and exercise varying degrees of the same skills. Interaction among the employees and their interrelated work requires the application of similar working conditions by their employer.

There is in effect a bargaining unit at Tacoma Community College (HRU 14) which includes office, clerical and food service personnel who are represented by the Tacoma Community College Staff Association; however, no bargaining unit for the custodial/ maintenance personnel at Tacoma Community College was established by the permanent personnel committee prior to July 1, 1969, nor has a bargaining unit been established by the Higher Education Personnel Board since that time.

CONCLUSIONS

The Higher Education Personnel Board has jurisdiction over the subject matter and over the parties interested herein.

II.

The common working conditions, hours of employment, and participation in the International Union of Operating Engineers, Local 286, indicate a community of interest which demonstrates

RE: LEGISLATIVE ACTIONS RELATING TO BUDGET

I would like to outline to you for your benefit and for the benefit of your board of trustees and others who are involved in the budget planning for the operation of your district for the next year. Some of the actions which the legislature has taken which will have impact on your planning. In this respect, I would like to talk about four items:

- I. Sabbatical Leaves
- 2. Increments
- 3. Proviso that no college will receive less money next year than this year
- 4. Salary increases

Sabbaticals

A floor amendment was adopted yesterday when the Senate debated Engrossed Substitute House Bill 151, which is the general operating budget. That amendment introduced by Senator John Stender won the support of the Senate and declared that no part of the appropriation would be used for sabbatical leaves. As you know, the budget will go to Conference Committee, and the Conference Committee probably will ask for powers of free conference and, therefore, any and all aspects of the budget will be subject to change. What will happen to the sabbatical leave provision in the Conference Committee is in doubt. However, it would be very prudent on your part to provide some kind of qualification so that if that proviso stays in the budget prohibiting the use of any part of the funds for support of sabbatical leaves, that you have a position in which the leaves could be cancelled if it became necessary. I believe that the earlier this fact is made known to the faculty, the better off we will be.

Increments

In the budget as prepared by the Senate Appropriations Committee and sustained in the Ways and Means Committee, there was a proviso that said that no increments would be paid out of the general operating budget. That proviso has been taken out, and it will be possible to pay increments from the general operating budget for the next two . years. This has obvious budget implications for you in your planning. It has been my position all along that the increments represent an agreement between the boards of trustees and the faculty and classified personnel. This agreement represents, in my judgment, a moral commitment, Therefore, I am suggesting to you that in your planning you allow for the payment of increments to the professional and classified personnel.

Proviso

A proviso was attached in the Ways and Means Committee which said that no community college would receive less money in the next biennium than it is receiving in the current 1970-71 academic year. Attempts were made to strike that proviso, but the attempts failed. Therefore, the proviso is still in the budget. If the proviso stands in the Conference Committee, then it means that we must find a way to provide about \$600,000 in order to meet the conditions of the proviso. The only way in which this can be done would be to take money from those colleges now scheduled under the formula to receive increases and to re-allocate those monies to the five colleges who under the formula are scheduled for reductions. I would like to see an attempt made to identify the five colleges as special problems which the legislature must take into consideration and that the legislature should make a special appropriation to take care of those institutions. In this way, there would be a subsidy for the colleges faced with severe hardships and at the same time not subsidize them by subtracting the funds that are sorely needed for other colleges who are confronting growth and other problems. would appreciate whatever you can do to encourage the legislature to recognize these as special problems requiring a special appropriation.

Salary Increases

There is a proviso in the budget that no money from the general operating budget will be used for increases in salaries. This is a factor which must be taken into consideration in your budget planning for the next year. I have said repeatedly, and I will reiterate again, that it is the position which I have taken and which I will encourage you to take that if that proviso is in the budget, that we do not provide any salary increases for any employees. To put this in a different way, unless the legislature makes a specific appropriation earmarking funds for increasing salaries, it is my position that the local boards of trustees in negotiating with faculty should take the position that there is no money for general salary increases. The only alternative is to increase salaries by reducing funds that are needed to support programs. The programs are so severely jeopardized at the present time, that to use any of those funds to provide salary increases-no matter how warranted they are--would be impossible at this time.

Conclusion

Please bear in mind that the budget still has a long ways to go in that changes are still likely. However, we cannot wait until May 10

when the legislature will reach final action on the budget before proceding with our planning for the next year. Therefore, the comments which I have made here I hope will serve as guidelines for you in that planning.

After carefully looking at the proposed equipment and material list of the apparent low bidder Tyee Construction Company, I must recommend the bid be rejected.

Shown on the attached page, are specific areas where the proposed equipment of Tyee Construction, does not meet the Television Distribution System specifications.

In general; The proposed strip amplifiers, pre-amplifiers and UHF to VHF converters, are of insufficient output capability to provide for the overall distribution losses in the system. The end results of this would be a finis hed system which would be unable to provide the minimum 1500 microvolt signal at each TV outlet as specified in 2.09.

The wall taps and line splitters proposed by Tyee Construction, would restrict the capability of the distribution system to TV channels 2 to 13. When using splitters and wall taps, as specified in out design, the system has the capability of future sub-carrier information, and UHF channels 14 to 83, in addition to the channels between 2 to 13.

Shown on the attached page are reasons for rejection of each item which does not comply with the design specifications.

Subject: APPROPRIATIONS - SENATE VERSION

The operating budget is now in a Joint Conference Committee (Senators Durkan, Dore, and Atwood; and Representatives Goldsworthy, Kopet, and Brouillet).

The Senate figure for the Community College System stands at \$115,396,486--or \$3,026,156 less than the Governor's budget and \$1,636,401 less than the House approved version. It represents a \$910,354 increase over the Senate Appropriations version.

Although the situation might change, the bill <u>presently</u> contains the following sections of special interest:

- a. Section 106 directs a reduction in state salaries by varying percentages for all individuals whose present compensation exceeds \$15,000 per annum.
- b. Section 107 declares that it is the intent of the Legislature that no salary increases be granted during the 1971-73 biennium.
- c. A proviso in Section 1 prohibits the expenditure of any appropriated funds for sabbatical leaves.
- d. A proviso at the end of the community college appropriation prohibits any college from suffering any reduction in allocation below that established for 1970-71, except in the case of a projected decline of FTE enrollment.
- e. A provision in the Senate Appropriations budget which would have prohibited the payments of increments has been stricken.
- f. The fee waiver provided for in H. B. 740 (tuition increase bill) has been reduced from 6 per cent to 3 per cent in the Senate bill. However, in the event that H. B. 740 does not pass (and this is a distinct possibility) we would still be required to waive 3 per cent of all fees collected--without additional tuition and fees to cover the cost.

> g. Section 96 establishes a <u>minimum</u> of 15 average weekly classroom contact hours for community college instructors.

The dollar effect on TCC would be as follows:

Highest estimate--increased dollars for 1971-72 \$ 51,858

Low estimate (see d. above) calculated effect on TCC--subtract \$11,605 from increased dollars 1971-72 leaving increase of\$ 40,253

It should be understood that even these additional dollars will not be available unless we serve the 191 additional FTE students.

If the operating budget bill comes out of the Conference Committee without an assist from new taxes we face an extremely austere biennium. Some will experience salary reductions. Our ability to provide increments is in doubt.

Our problems would be a little less complex if we were able simply to maintain status quo. We cannot. Without additional enrollment next year's budget would be <u>smaller</u> than or the same as this year. It would also close the "open door." Without increased effort in occupational programs we do violence to one of our top priority objectives, perpetuate a low dollar allocation base, and reduce our allocation by 44 per cent per occupational FTE.

During the next weeks I will be discussing with you and with faculty, student, and staff leaders some of the alternatives which will be open to us if operation budget figures do not increase. Among those alternatives are the following:

- 1. The establishment of a minimum class size. This would reduce the number of courses--particularly at the sophomore level.
- 2. Reassignment of present staff, wherever possible, to occupational courses and programs for at least part of their load.
- 3. Curtailment of all purchases, including library acquisitions, to the level absolutely necessary for program survival.
- 4. Non-renewal of contracts with the Tacoma and Peninsula School Districts for adult education programs. We will have to handle these with our own staff.

- 5. Cancellation of institutional memberships in state and national professional organizations such as the AAJC.
- 6. Continuation of our current stringent travel policy.
- 7. The close examination of any means by which management and instructional economies can be effected.

It is my sincere intention at this time to see to it that the budget we develop for TCC will enable us to operate next year without a curtailment of faculty or staff. We will need them all. I am convinced, however, that the coming biennium will test the talent and the commitment of all of us. I am confident that we are equal to the task.
