SIX STUDENTS EARN PRESIDENT'S MEDALS

Governor Dixy Lee Ray, during the TCC commencement ceremonies June 9, awarded the president's medals to six TCC students who graduated from the college with a straight "A" average.

Linda Kay Hansen, a 34-year-old nursing graduate, maintained her 4-point average while earning two degrees simultaneously: an Associate degree in liberal arts and an Associate degree in technical arts. She is a graduate of Franklin Pierce High School and has found work at Good Samaritan Hospital.

Larry Duayne Gallegos earned his 4-point average while earning an Associate degree in arts and sciences and an Associate degree in technical arts in computer programming. He plans to attend the University of Puget Sound this fall.

Nineteen-year-old Rebecca Ann Berntson maintained her perfect score while earning her Associate degree in arts and sciences. She is a graduate of Wilson High School and plans to attend the University of Washington. Her father, Lloyd Berntson, is TCC chairman of the division of English and communications.

Lois Kennedy, also an arts and sciences Associate degree graduate, plans to take her straight "A" record to the University of Puget Sound where she intends to study philosophy. She has lived in the Tacoma area since 1932, except for six years spent in Texas. She is a graduate of St. Leo's High School in Tacoma.

Delores L. Krull, Associate degree in arts and sciences, earned her high school diploma at Thorp High School in Garden City, North Dakota. She is a Tacoma resident and earned her perfect score over a period of four years as a part-time TCC student.

Michel Yvette Knighton earned her Associate degree in arts and sciences and her award attending evening classes at TCC. She graduated from Wilson High School in 1974 and plans to attend Pacific Lutheran University.

MAINTENANCE CUSTODIAN POSITION OPEN AT TCC

A position is available at TCC for Maintenance Custodian II. The TCC examination announcement is No. 77-5.

The individual selected is responsible to the buildings and grounds supervisor for performing skilled general maintenance and custodial work for buildings, facilities or equipment; or assist in the operation of plant boilers and related equipment.

Minimum qualifications are at least two years of experience in general electrical maintenance work and custodial work. Possession of a valid motor vehicle driver's license is required.

Salary is current HEPB salary range (39) \$713 to \$913 per month. Job entry at minimum salary step.

An official application and supplemental application (job element examination) form completed by applicants will be scored by ranking each applicant's experience, training and background against the elements of this position. The top three candidates will be referred for interviews in the order of their ranking on the employment list established by this examination. The eligibles not selected remain on the list for certification to future vacancies.

BOARD HIGHLIGHTS

Alan P. Vandevent, corporate secretary and attorney for the Weyerhaeuser Company, was elected chairman of the TCC Board of Trustees at their June meeting last Thursday afternoon.

Vandevent was named to the TCC Board by Governor Dixy Lee Ray April 4.

Ellen Pinto, Board chairman for 1976-77, was elected vice-chairman.

In other business the Board accepted the associated students services and activities fee budget of \$175,000. The funds include \$69,805 for programs such as athletics, the campus newspaper, drama, music and student government.

Services including the child care center, McNeil Island special services, student help, tutoring and women's programs account for \$70,810. The remainder of the budget is assigned to all other projects including clubs, resource development, the spring festival and the student literary magazine.

The revenue for the student services and activities budget is expected to come from \$14.50 per full time student granted the student activities fund, plus a \$2,000 cash carry-over.

During the meeting James Smith, retiring member of TCC's custodial staff, was presented with a plaque honoring him for nine years of service to the college.

Several items of information were presented to the Board including the tentative 1977-78 operating budget, the 1977-78 college bookstore and food service operations budgets. The budgets were lodged with the Board for study.

Correspondence reviewed by the Board included the authorization of \$522,187 spent on Basic Educational Opportunity grants to TCC students through last June 30, and notice of \$13,088 awarded veterans attending the college spring quarter 1977.

The Board also approved a new refund policy. Students will now be able to receive a full refund if they withdraw prior to the first day of classes, or if a proven medical or psychological reason is presented to the dean of student services any time during the school year.

Eighty per cent of tuition and fees will be refunded students who withdraw from all classes within ten calendar days of the first day of classes. After the ten days, a student will receive a 20 per cent refund following an exit interview with a member of TCC's counseling staff.

Carl Brown presented a memorandum from Tim Lowenberg, assistant attorney general, endorsing the legality of the recent college closure June 13 through 15, and the fact all affected employees will be paid their normal salary or wages.

Dr. Rhule presented to the Board the following letters of resignation: P.5
letter of resignation from TCC, effective June 30, 1977, from Joan Royce; letter of resignation from TCC as custodian, effective June 1, 1977, from James Smith; letter of resignation from Mr. Ed. Fisher, effective June 10, 1977, as athletic director; letter of resignation from Mr. R. W. Giroux as golf coach.

Another letter from William Oliver commended Carolyn Simonson for her work with the Washington Commission for the Humanities. A letter inviting Mary Kennedy to serve on the College Store Journal Editorial Advisory Board Committee was also part of the Board information.

The Board also agreed to participate in the vacation of a 33-foot wide parcel of land on South 18th Street between Pearl and Visscher.

The Board set the next meeting for July 28 at 2 p.m. in the Binns Room of the College.

PRESIDENT'S MEDAL WINNER STUDIED ON LIVING ROOM FLOOR

Studying hard enough to pick up straight A's in two degrees at once usually means a cozy book nook with no distractions.

TCC student Linda Kay Hansen found she couldn't concentrate that way. She kept worrying about her six kids, aged eight to 15, romping on the other side of the closed door.

So she moved books and baggage to the middle of the living room floor. Last Thursday evening she was awarded the president's medal by Governor Dixy Lee Ray at TCC's commencement ceremonies.

She picked up perfect grades while earning her Associate degree in technical arts (nursing) and her Associate degree in liberal arts.

"I had so much to do when all the kids were little at once that when my youngest went to kindergarten I found I had nothing to do at all, so I decided to go to school," she explained.

Since the Hansen homestead near Summit also contains two horses, geese and several basset hounds for breeding purposes, it is hard to imagine that there was nothing to do there.

However, Linda was interested in nursing and soon found herself enrolled in the program.

"I had spent so much time sitting around emergency rooms as the kids were growing that I figured I had a head start," she laughed.

Husband Matt and all six children were present for the ceremony, which was highlighted for Linda by the chance to shake the governor's hand.

"That was the biggest thrill of the whole thing," observed the new graduate.

Linda will have to waste no time job hunting. She has already been hired by Good Samaritan Hospital.

SUBJECT: WFSE-MANAGEMENT COMMITTEE MEETING MINUTES, JUNE 8, 1977

The meeting [redacted] neither party had
additional items for committee consideration.

- I. TRANSFER PROCEDURE - After a review of the transfer procedure, WFSE representatives questioned the necessity of including one of the criteria to be considered by the employing official in the acceptance or rejection of an employee requesting a lateral transfer. The Management representatives explained why they included the criterion but were receptive to the points presented by WFSE. Both parties agreed to delete the criterion; however, the Management representatives requested that the committee withhold its endorsement of the document until it had been reviewed by other management personnel.
- II. CLASSIFIED EMPLOYMENT ORIENTATION CHECK LIST - The committee engaged in a brief discussion pertaining to the revisions on the Classified Employment Orientation Check List. No additional changes were suggested; however, both parties agreed to allot more time for review of the document.
- III. PROCEDURES FOR APPROVAL OF WFSE-MANAGEMENT AGENDA AND MINUTES - To decrease the possibility of one-dimensional views being presented in the production of WFSE-Management Committee minutes, both parties agreed to comply with the provisions stipulated in Article 5 - UNION MANAGEMENT RELATIONS, Section 5.10, entitled MINUTES.
- IV. KEY SURVEY - Of 94 classified employees, including supervisors and physical plant workers, 84 (87%) employees responded to the key survey.

Of the 84 respondents, 62 (74%) indicated that their desks had keys and that they were able to lock their desks. Included in this number were those respondents who did not work at desks and stored their belongings in a safe place.

The remaining 22 (26%) respondents indicated that they worked at desks which could not be locked, or they did not work at desks and had no safe place to store valuable items. Included in this number were those respondents who failed to follow the directions of the survey.

Management indicated that it would initiate action to comply with the intent of Article 14.6 (b) as early as June 20, 1977.

V. OTHER

- A. Information was provided pertaining to the partial closure of the College for electrical repairs on June 13, 14 and 15. Management placed emphasis on the fact that several work stations would be functional, requiring some employees to work on those days.
- B. WFSE representatives reported some health-related problems and suggested solutions which would require the support of both management and employees.

The meeting adjourned at 4:00 p.m.
