Dear Rich:

The Seattle Regional Office of the Veterans Administration has informally notified our community colleges of its intent to implement DVB Circular 20-77-16 (attached). That Washington, D.C. directive, dated February 9, 1977 and titled "Measurement For Payment Purposes" states in part "In no case will a course be measured as full time when less than...12 standard class sessions per week...are required." The effective date is October 26, 1976 and "where applicable, overpayments would be created from the beginning of such terms and school liability considered."

We have been informed by the regional office that they interpret the directive to mean that veterans may only be paid for actual in-class time. Our colleges teach students by the "traditional in-class" method but also employ extensive use of contracted learning, seminar courses, independent study, conference courses and cooperative education. The V.A. regulation if implemented would penalize veterans who enroll in courses taught by those alternate approaches.

The community college presidents consider DVB Circular 20-77-16 implementing V.A. Regulation 14272 (D) to be an unjustified and improper intrusion into the educational practices of their colleges. It is at their urging that I request your advice and assistance in seeking court action to prohibit the implementation of V.A. Figulation 14272 (D).

Should you advise that court action is appropriate, we will also need your opinion of the advisability of pursuing a SBCCE suit on behalf of the community college system as opposed to individual suits by each college.

The V.A. regional office has simply mailed the circular to the colleges without a cover memo detailing their plans for enforcement. Also attached are proposed rules as contained in the April 5, 1976 Federal Register which may have been the basis for the V.A. circular.

Your assistance in this matter will be greatly appreciated. If implemented, this regulation would do serious harm to the educational opportunities of student veterans. I plan to discuss this issue with the SBCCE at their March 31 meeting and, if possible, would like your advice at or before that meeting.

Old Business

- Course Modification: Banking & Finance 148 (1 cr/l lec/0 lab) Credit Change: from 1 to Τ. 2 credits.
- New Course Adoption: Banking & Finance 111 (3 cr/3 lec/0 lab) Negotiable Instruments and 2. the Payments Mechanism; To be offered Winter Quarter; Associate Degree Distribution: Other
- 3. New Course Adoption: Banking & Finance 186 (3 cr/3 lec/0 lab) Commercial Banking; To be offered Winter Quarter; Associate Degree Distribution: Other
 - MOTION: It was moved by Jack Heinrick and seconded by Paul Michaels that the course modification for Banking & Finance 148 be approved, and that Banking & Finance 111 and Banking & Finance 186 be approved for introduction into the curriculum. The motion carried unanimously.
- Course Modification: Biology 100 Basic Ecology (5 cr/4 lec/2 lab) Number change from: Biology 100 to Biology 105 Necessary due to redesign of General Biology Course.
 Course Modification: Biology 101 General Biology (5 cr/4 lec/2 lab) Number and Title
- Change: From Biology 101 General Biology to Biology 100 Introduction to Biology. The course is redesigned as an introduction for non-majors.
- New Course Adoption: Biology 101 General Biology (5 cr/3 lec/4 lab) To be offered Fall 6. Quarter. Associate Degree Distribution: Math/Science.
 - MOTION: It was moved by Doreen Amoroso and seconded by Bob Thornburg that the course modifications for Biology 100 and 101 be approved, and that the new course proposal for Biology 101 be adopted into the college curriculum. The motion carried unanimously.

(Jack Hyde explained that the above changes were due to a renumbering of the system with an introduction for majors starting with Biology 101. He said the problems with the Allied Health Division had been resolved.)

- New Course Adoption: Oceanography 103* Life in the Ocean (5 cr/3 lec/4 lab) To be 7. offered Spring Quarter; Associate Degree Distribution: Math/Science; Prerequisite: Oceanography 101 or Biology 100 or Biology 101 or permission of instructor.
 - MOTION: It was moved by Bill Wittenfeld and seconded by Bill Muse that Oceanography 103* be approved by the Curriculum Committee. The motion carried unanimously.
- 8. New Course Adoption: Music 170/270* Swing Choir (3 cr/0 lec/6 lab). To be offered Fall, Winter, Spring Quarters; Associate Degree Distribution: Humanities

It was moved by Harland Malyon and seconded by Paul Michaels that Music MOTION: 170/270* be approved for introduction into the college curriculum.

- AMENDMENT TO THE MAIN MOTION: It was moved by Harland Malyon and seconded by Jack Heinrick to amend the motion for Music 170/270* to read that a limitation of 9 credits apply to the Humanities distribution for Associate degree requirements.
- AMENDMENT TO THE AMENDMENT: It was moved by Ed McNeal and seconded by Harland Malyon that the amendment to the main motion be changed to read 10 credits rather than 9 credits for Music 170/270*.

The amended amendment passed unanimously; the amendment to the main motion passed 7 ayes; 5 nayes; the main motion as amended passed unamimously.

- 9. New Course Adoption: History 94 Washington State History (5 cr/5 lec/0 lab) To be offered Fall, Winter, Spring Quarter; Associate Degree Distribution: Social Science
 - MOTION: It was moved by Jack Heinrick and seconded by Jack Hyde that History 94 be approved for adoption. (It was noted that this course is a requirement for high school completion.) The motion carried unanimously.

New Business

1. Pilot & Experimental Course: Biology 198 - Our Undersea Frontier (3 cr/3 lec) To be offered Spring Quarter; Distribution: Math/Science

Dr. Ronald Magden explained the new Biology 198 pilot and experimental course. Information has been disseminated to teachers in the Tacoma and Clover Park school districts. Dr. Magden also mentioned that as part of the class the ASB Program Board has contracted Jim McDonald, a member of the Jacques Cousteau team, to speak on campus. Class activity is being coordinated by Dick Perkins. The 3-hour course will consist of slides/film/lecture/ discussion/field trips and will run from April 20-30.

MOTION: It was moved by Lloyd Berntson and seconded by Harland Malyon that Biology 198 be approved by the Curriculum Committee. The motion carried unanimously.

 Course Modification: Biology 205 - Change of Number, Title, Credits - To: Biology 120 -Genetics (5 cr/5 lec) From: Human Genetics (3 cr/3 lec/0 lab)

Dr. Jack Hyde explained that this course, which has not been offered recently, was formerly taught in conjunction with the University of Washington and dual credit was awarded. Dr. Hyde said he would check to see if this practice is still feasible. Concern was expressed that no prerequisite was necessary. Bill Muse explained that the course is for non-majors and is intended for an introduction to the basic concepts of genetics.

- 3. New Course: Engineering 220 Introduction to Mechanics of Materials (4 cr/3 lec/2 discussion) Prerequisite: Engineering 180; Distribution: Math/Science
- 4. New Course: Engineering 299 Independent Study (Variable Credits 1-5)
- 5. New Course: Physics 299 Independent Study (Variable Credits 1-5)

Ken Gentili explained the need for Engineering 299 and Physics 299 for students who have projects that go beyond the regular sequential classes in each discipline. Mr. Gentili also explained that Engineering 220 is offered at the University of Washington at the sophomore level and is necessary at TCC for the engineering program.

New Course: Math 94 - Basic Voc.Tech. Math I (Variable 1-3 Cr.) Prerequisite: Math 86
 New Course: Math 95 - Basic Voc.Tech. Math II (Variable 1-2 Cr.) Prerequisite: Math 94

Bill Wittenfeld said that the two new proposed courses are in the vocational math area and would draw clientele from on campus and the vocational schools in the area. He explained the need by students going into vocational programs without enough mathematics background for their apprenticeship work. He said the courses would be developed to fit various areas.

- 8. Course Modification: FROM: Study Skills 45 to English 83 Vocabulary Development; to place the course in the proper sequence of the English 80 series. Course Modification: FROM: Study Skills 46 to English 84 - Spelling Review; to place the

 <u>Course Modification: FROM: Study Skills 41 to Reading Skills 80.</u> Reason: The emphasis in Study Skills 41 is on reading. Also, this change will place all developmental workshop courses in the 80 numbering system.
- Course Modification: Number Change: FROM: Study Skills 47 to Study Skills 80 Library 11. Orientation. Reason: To place developmental workshop courses in the 80 numbering system.

Lloyd Berntson explained that the course modifications requested are "housekeeping" items and move developmental courses into the numbering series utilized for the developmental courses.

12. Course Modification: Title Change: Women's Studies 100 FROM: What About Woman? TO: Assertiveness Training.

Dr. Ronald Magden explained that the title is to better describe the content of the class and to encourage male enrollment.

Other

- 1. Task Force to Study Associate Degree Requirements Ed McNeal expressed concern that there should be a maximum number of courses in the 90's that would apply toward the Liberal Arts degree. A task force will be assigned to research the Associate degree requirements at TCC and other institutions. Information from the task force's work will be taken to the full faculty.
- 2. Department Chairman Elections Dr. Rhule reminded the members that names of elected department chairmen are due in May for recommendation to the president.
- 3. FTE Count Dr. Rhule announced that the FTE count for spring quarter is now at 3,085.
